



CENTRAL DISTRICT OF CALIFORNIA: WESTERN DIVISION

■ Serving a State Agency or Local Government Agency

If you are a plaintiff and you have filed a Complaint, you must arrange for delivery of a copy of the Summons and Complaint to each defendant in your case. This is called "service of process." However, a plaintiff cannot serve the Summons and Complaint. The person who serves the Summons and Complaint (the "server") must be at least 18 years old and not a party to the lawsuit. Your server can serve a defendant that is a state or local government agency by doing either of the following:

1. Hand deliver the Summons and Complaint to the head of the agency. Information on the head of agencies within California can be found on the California Roster, available on the Secretary of State's website (www.sos.ca.gov) or through the county clerk.



2. Leave the Summons and Complaint at the agency's place of business.

Your server may leave the Summons and Complaint at the **agency**'s **usual place of business** with somebody in charge who is at least 18 years old. At that time, your server must tell the person that the papers are a Summons and Complaint for the agency. The server must then mail a second copy of the Summons and Complaint to the address where the papers were left, addressed to the head of the agency.

Because serving the Summons and Complaint can be complicated, please read Rule 4 of the Federal Rules of Civil Procedure and consider consulting an attorney.

DON'T FORGET!

You must file **a proof of service form** signed by the server (see attached form) so the court knows that you served the right defendant.
