1 Pursuant to the Parties' Joint Stipulation to Continue Hearing on Motion to
2 Dismiss and for any Hearing on the Motions to be Conducted in Person (the
3 "Stipulation") and good cause appearing therefore, IT IS ORDERED THAT:

4 1. The hearings on Defendant City of Fontana's Motion to Dismiss
5 Plaintiff's First Amended Complaint pursuant to Fed. R. Civ. Proc. 12(b)(6) filed on
6 October 23, 2025 [ECF No. 41] and Defendants 4LEAF, Inc., Craig Tole, and Pete
7 Roque's Motion to Dismiss Plaintiff's First Amended Complaint pursuant to Fed. R.
8 Civ. Proc. 12(b)(6) and 12(b)(1) filed on November 4, 2025 [ECF No. 45] shall be
9 continued from December 19, 2025 to January 9, 2026 at 2:00 p.m.;

10 2. If the Court holds a hearing on the Motions, the hearing shall be
11 conducted in person with all counsel to attend in person; and

12 3. Plaintiff's request to appear in-person is **DENIED as moot.** [Dkt. No.
