Pursuant to Northern District of California Civil Local Rule 7-12, Plaintiffs and Defendants American Surety Company, William B. Carmichael, and Indiana Lumbermens Mutual Insurance Company, (together, “Settling Defendants,” and with Plaintiffs, the “Parties”) in the above-entitled Action stipulate as follows:

WHEREAS, on February 13, 2026, the Parties reached an agreement in principle to settle all claims in this Action against the Settling Defendants;

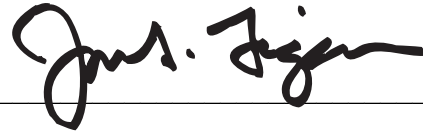
